Objectives and Investment Policy

Templeton Global Climate Change Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity securities issued by companies located in any country which recognise and adapt to the long-term financial risks and opportunities presented by climate change and resource depletion across all sectors, and are, therefore, better prepared for a transition to a low carbon economy.

The Fund can invest to a lesser extent in:

- units of other mutual funds and exchange traded funds (limited to 10% of assets)
- cash or money market securities, convertible securities or debt securities
- derivatives for hedging and/or efficient portfolio management

The investment team uses in-depth analysis to select individual equity securities of companies with favourable environmental, social and governance attributes that it believes are undervalued and will provide the best opportunities for increased value over the long term.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the

result of increasing the value of the shares.

Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.

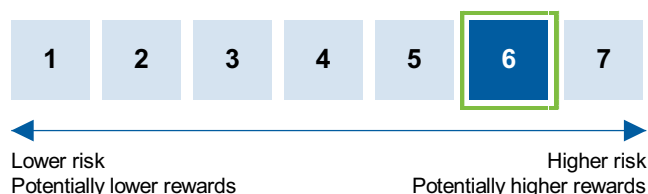
Money market securities: Short-term loans (typically of less than 397 days) made to their issuers by the purchasers of the security.

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

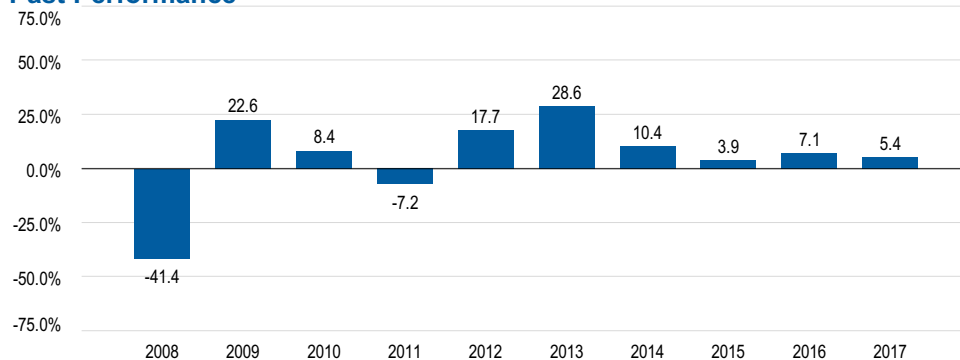
