#### **Objectives and Investment Policy**

Franklin Mutual U.S. Value Fund (the "Fund") aims to increase the value of its investments and, secondarily, to earn income over the medium to long term.

The Fund invests mainly in:

 equity securities issued by companies located in the U.S. (representing at least 70% of the Fund's net assets)

The Fund can invest to a lesser extent in:

- equity securities issued by companies involved in mergers, consolidations, liquidations or other major corporate transactions
- debt securities of any quality (including lower quality debt such as non-investment grade securities) of companies involved in reorganisation or financial restructuring
- equity and debt securities issued by corporations located outside of the U.S.
- derivatives for hedging and/or efficient portfolio management

In exceptional market circumstances, the Fund may temporarily hold a greater amount of cash in times where the manager believes that the markets are experiencing excessive volatility, a prolonged general decline or other adverse conditions.

The investment team uses in-depth, fundamental research and analysis to find and purchase those equity and debt securities that are believed to be trading at

a discount.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

#### Terms to Understand

**Debt securities:** Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

**Derivatives:** Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Equity securities: Securities that represent an ownership stake in a company.

**Hedging:** A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.


